2. Value added courses for students

2. Minutes of the last meeting were read and confirmed.
3. Discussion regarding the new curriculum of B. Tech./M. Tech./MBA/B. Voc. Under autonomy was carried out. IQAC members suggested to include the courses which will enhance the career opportunities amongst the students of B. Tech. / M. Tech./MBA/B. Voc. It is also suggested to include various verticals in MBA which will provide the career-oriented path to the students. It is suggested to include additional assessment tools for evaluation of the student's performance.
4. Presently online teaching is carried out mostly based on the use of power point. To improve the quality of teaching learning, it is suggested to install the online teaching set-up in the classrooms for blended mode of teaching learning and also to teach the analytical courses on the green board.
5. In view of the Autonomy conferred to the institute, it is suggested to conduct expert talks and workshops in view of implementation of autonomy, curriculum design and development, evaluation etc. Experts from the autonomous institutes may be invited to share their experiences.
