2. To facilitate Online Teaching learning process

**Action Taken:** To improve the teaching learning process, web camera setups are installed in all the classrooms. This has enhanced the teaching of the courses specially the analytical courses and the blended learning is also started with the installation of set-up.

3. To conduct sessions on curriculum design, evaluation, and Autonomy implementation

**Action Taken:** In order to prepare for the autonomy, session from experts were arranged pertaining to Autonomy implementation, Curriculum Design and Development, Assessment and evaluation.

Following points were covered in the meeting.

1. Dr. Santosh Bhosle welcomed all the members for the meeting.
2. Minutes of the last meeting were read and confirmed.
3. Governing Body Chairman has taken the workshop on preparation of Project Planning Matrix (PPM) and preparation of perspective plan based on it. Based on this workshop, all the faculty members will prepare the individual PPM and then it is combined to prepare departmental and institute level PPM. Discussion regarding the same is carried out. All the IQAC members have suggested to carry out the SWOC analysis of the departments and institute and based on that PPM can be prepared.
4. As the institute has started in offline mode post COVID, members suggested to start the courses, trainings for the upskilling of the students so that the gap during COVID pandemic can be fulfilled.
5. Academic planning for the next semester of higher classes is to be done. Based on the COVID situation, classes will be conducted in offline/online/blended mode. It is suggested to work on the academic planning rigorously and more focus has to be given on improving the learning experience of the students.
